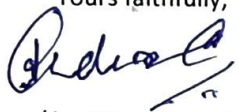

NATIONAL CONSUMERS DAY CELEBRATION

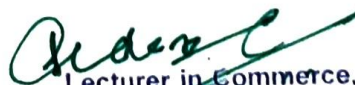
