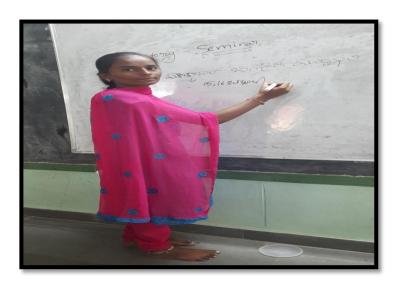

Brief Report: He masterminded the unification of Germany in 1871 and served as the first chancellor of the German Empire until 1890, in which capacity he dominated European affairs. He had served as chancellor of the North German Confederation from 1867 to 1871, alongside his responsibilities in the Kingdom of Prussia. Bismarck's Realpolitik and powerful rule at home led to him being called the Iron Chancellor. Juggling a very complex interlocking series of conferences, negotiations and alliances, he used his diplomatic skills to maintain Germany's position. Bismarck's diplomacy of Realpolitik and powerful rule at home gained him the nickname the "Iron Chancellor". His main goal was to further strengthen the position of Prussia in Europe. Bismarck had a number of primary aims: to unify the north German states under Prussian control. to weaken Prussia's main rival, Austria, by removing it from the German Federation.

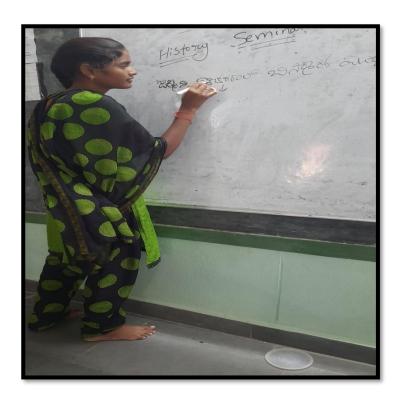

The four major reasons behind the unification of Germany are the role of Bismark, the strength of the Prussian economy, the decline of Austria, and the military power of Prussia. The economic strength of Prussia was one of the most important reasons behind the unification of Germany. Conclusion. The unification of Germany fundamentally altered the delicate "balance of powers" established by the Congress of Vienna with the creation of a large, wealthy, and powerful nation-state in central Europe.

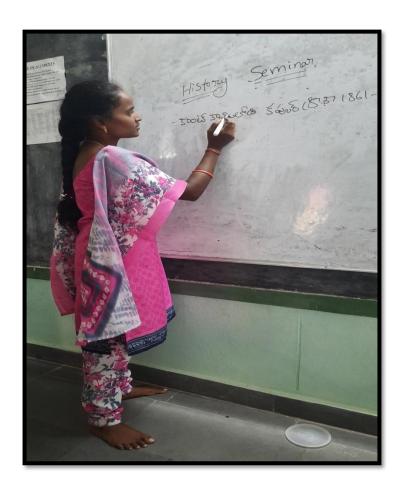

Students will develop persuasive speech, present information in a compelling, well-structured, and logical sequence, respond respectfully to opposing ideas, show depth of knowledge of complex subjects, and develop their ability to synthesize, evaluate and reflect on information. **Brief Report:** As prime minister, Cavour successfully negotiated Piedmont's way through the Crimean War, the Second Italian War of Independence, and Garibaldi's Expedition of the Thousand, managing to maneuver Piedmont diplomatically to become a new great power in Europe, controlling a

managing to maneuver Piedmont diplomatically to become a new great power in Europe, controlling a nearly united Italy that was five times as large. He was a celebrated personality during the period of the unification of Italy. He was the prime minister who actively participated in the movement to unify Italy. He was a brilliant and tactful diplomat. He doesn't belong to a royal family. A skilled diplomat, Cavour secured an alliance with France. The Franco-Austrian War of 1859 was the agent that began the physical process of Italian unification. The Austrians were defeated by the French and Piedmontese at Magenta and Solferino, and thus relinquished Lombardy. Cavour campaigned to expand Piedmont at Austria's expense. After Austria defeated Italy in the war of 1849 (Treaty of Milan, August 1849), he concluded that it was necessary to seek outside help to achieve Italian unity under Piedmont's authority.

The assassination of Archduke Franz Ferdinand, heir to the throne of Austria-Hungary, by Gavrilo Princip in Bosnia is widely accepted as the starting point for World War I.
